

AMIS Student and Volunteer Participant Assumption of Risks, Waiver, and Release Policies

Georgia COVID-19 Assumption of Risk:

Under Georgia law, there is no liability for an injury or death of an individual entering these premises if such injury or death results from the inherent risks of contracting COVID-19. You are assuming this risk by entering these premises.

1. Waiver and Release. Participant hereby releases, waives, and forever discharges and holds harmless AMIS and its officers, directors, trustees, employees, staff, volunteers, members, agents, successors and assigns from any and all manner of actions, causes of action, claims, charges, complaints, promises, agreements, demands, costs, damages, liabilities, liens, losses, obligations, expenses, attorneys' fees and costs, claims for punitive or exemplary damages, and compensation of any nature whatsoever, known or unknown, in law or in equity, arising out of or relating to AMIS Services.

Participant understands that this Release discharges AMIS from any liability or claim that Participant may have against AMIS, including but not limited to personal or bodily injury, illness, death or property damage, and regardless of whether caused in whole or in part by an act or omission of AMIS or its officers, directors, employees, agents or otherwise. Participant further understands that AMIS does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance in the event of injury or illness.

- 2. **Medical Treatment.** Participant releases and forever discharges AMIS from any claim whatsoever arising or related to any first-aid, treatment, or other services rendered in connection with an emergency during while receiving or participating in AMIS Services.
- 3. **Assumption of the Risk.** Participant expressly and specifically accepts and assumes all risks of any injury, damage or harm that may arise during or result from AMIS Services, whether or not caused in whole or in part by the negligence or other fault of AMIS.
- 4. **Photographic Release.** Participant hereby grants and conveys to AMIS, without limitation, all rights, title, and interest in any and all photographic images and video or audio recordings made by AMIS, including but not limited to any royalties, proceeds, or other benefits derived from such photographs or recordings. Participant further grants and conveys AMIS the right and sole discretion to publish Participant's name, image, voice or likeness in any and all media.
- 5. **Governing Law.** Participant expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Georgia. Participant further agrees this Release shall be governed and construed in accordance with the laws of the State of Georgia, excluding Georgia conflict of laws rules to the extent those rules would require the application of the laws of another jurisdiction. Participant and AMIS agree that the state and federal courts located in Fulton County, Georgia, shall have sole and exclusive jurisdiction over any disputes arising from AMIS Services, including this Release, and venue is proper in Fulton County, Georgia. If any provision of this Release is for any reason deemed to be invalid and/or unenforceable, Participant agrees that the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release, which shall continue to be enforceable.
